Federal Order Explanations

- 1) 1/1 must move in Road Column to N9.28 and await further orders. The division (and Hall's Battery) must remain in their Road Column along the Emmitsburg Road until they obtain new orders.
- 2) Take over as Acting Army Commander when Reynolds is killed. Howard cannot issue any orders until he begins a turn occupying N36.45 and sees "the lay of the land."
- 3) 2/3/1 is to move via S10.14 (Pitzer's Schoolhouse) to N61.35 to N35.31 and rejoin 3/1. *Double Quick* when able.
- 4) 1/3/1 and Cooper Battery are to move to S10.14 then follow Willoughby Run to the Fairfield road, then east to McPherson's Ridge and finally north to join the rest of the Corps.
- 5) These units are to rejoin their Command. 2/1 Div can *Double Quick* when able.
- 6) The player can assign any desired hex for the 1 Corps HQ that makes sense with whatever orders 1/1 has been given at this point, but that hex must be on or west of Seminary Ridge and east of West McPherson's Ridge.
- 7) 1/11, 3/11, 11 Corps HQ and Artillery: Move to N47.43
2/11: Move N49.45 and go into Army Reserve (4.3e)
- 8) Move to S6.52
- 9) Move to N48.46
- 10) Move to S14.67. They cannot leave this location until Williams enters play, move to join Command if he already is in play.
- 11) Move to the acting army commander and take over command of the army on the field until Meade arrives.
- 12) Move via the Emmitsburg Road and Millerstown Road to S12.42.
- 13) Move to S40.45. 1 Reg Arty, 4 Vol Arty and 1 Horse Arty move to S44.46. These units cannot be given new orders before 5:00 a.m. on 2 July. Automatically at 5:45 a.m. all these units move to the Army HQ to await new orders, if not already moving on different new orders.
- 14) Army HQ to move to N56.43.
- 15) Move to S5.41 as quickly as possible avoiding all enemy contact.
- 16) Move to S7.46.
- 17) Move to S8.58.
- 18) Move to S6.55.

- 19) Report to Hunt.
- 20) Move to S55.25. Deploy on line facing north. Attack north along Ridge Road, past Bushman Hill's west side to the Slyder Farm (S25.31).
- 21) Move to S51.10. Deploy on line facing north. Attack north along the Emmitsburg Road to capture the southern end of Warfield Ridge at S22.24 and cover the left flank of Kilpatrick's attack. Res/1 Cav is assigned to 3 Cav for this attack.
- 22) Newton arrives if Reynolds has been killed. He takes over command of 1 Corps. If Reynolds is not dead, Newton arrives with his division and does not take over 1 Corps.

Federal Order Explanations

- 1) 1/1 is to move to defend West and East McPherson's Ridge. It is authorized to attack to clear the area east of Willoughby Run as needed. Assign 1st Corps HQ any hex location west of Seminary Ridge and east of West McPherson's Ridge. Hall's Battery has not yet been assigned a posting hex.
- 2) Take over as Acting Army Commander when Reynolds is killed. Howard cannot issue any orders until he begins a turn occupying N36.45 and sees "the lay of the land."
- 3) Move N61.35 to N35.31 and rejoin 3/1. *Double Quick* when able.
- 4) 1/3/1 and Cooper Battery are to follow Willoughby Run to the Fairfield road, then east to McPherson's Ridge and finally north to join the rest of the Corps.
- 5) These units are to rejoin their Command. 2/1 Div can *Double Quick* when able.
- 6) The player can assign any desired hex for the 1 Corps HQ that makes sense with whatever orders 1/1 has been given at this point, but that hex must be on or west of Seminary Ridge.
- 7) 1/11, 3/11, 11 Corps HQ and Artillery: Move to N47.43
2/11: Move N49.45
- 8) Move to N48.46
- 9) Move to the acting army commander and take over command of the army on the field until Meade arrives.
